1. This has reference to recovery actions initiated against you under the provisions of the SARFAESI Act 2002.
2. 2. The intending Bidders /Purchasers are requested to register on portal <https://www.msicecommerce.com/auctionhome/ibapi> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers have to transfer the EMD amount using online mode in his Global EMD Wallet account by **25.03.2024 by 5.00 pm** (one day prior to e-auction). 3.
