## **E-AUCTION SALE NOTICE**

SALE OF IMMOVABLE PROPERTY MORTGAGED TO THE BANK UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT, 2002

Whereas Mr. Prem Shankar Malav S/o Ghanshyam Malav, Residential House situated at Dhakado ka Mohalla, Near Ramdev Temple, Vill Badgaon, Dist Kota, Rajasthan 324008 has borrowed monies from Indian Overseas Bank against the mortgage of the immovable properties more fully described in the schedule hereunder and upon classification of the account as NPA, the Bank has issued a demand notice under Section 13(2) of the SARFAESI Act, 2002 (Act) on 03.09.2019 borrowers Mr. Prem Shankar Malav S/o Ghanshyam Malav the Residential House situated at Dhakado ka Mohalla, Near Ramdev Temple, Vill Badgaon, Dist Kota, Rajasthan 324008 and the guarantors Mr. Satyanarayan Malav S/o Mr. Ram Swaroop Malav Ward No 7, Dhakado Ka Mohalla, Nautara Malliya, Nautara, Kota, Rajasthan 325204.to pay the amount due to the Bank, being Rs. 6,61486.34(Rupees Six lakhs Sixty-One Thousand Four Hundred Eighty Six and paise thirty Four) as on 31.08.2019 plus interest and cost payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment within 60 days from the date of receipt of the said notice.

Whereas the-borrowers & guarantors having failed to pay the amount dues in full to the Bank as called for in the said demand notice, the Bank has taken physical possession of the secured assets more fully described in the schedule hereunder on 30.07.2022 under Section 13 (4) of the Act with the right to sell the same in "As is where is" and "As is what is" basis under Section13(4) of the Act read with Rule 8 &9 of the Security interest (Enforcement) Rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking physical possession was intimated as Rs. 10,86,473/- (Rupees Ten Lakhs Eighty-Six Thousand Four Hundred Seventy-Three Only) as on 19.07.2022 payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

The dues of the borrower as on 26.02.2024 works out to Rs. 13,11,613.34 (Rupees Thirteen Lakhs Eleven Thousand Six Hundred Thirteen and paise Thirty-Four) plus interest and costs after reckoning repayments, if any, amounting to Rs. 92,014/subsequent to the Bank issuing demand notice.

- 1. The property (ies) will be sold by e-auction through the service provider <a href="https://www.mstcecommerce.com/auctionhome/ibapi">https://www.mstcecommerce.com/auctionhome/ibapi</a> under the supervision of the of the Authorized Officer of the Bank.
- 2. The intending Bidders /Purchasers are requested to register on portal <a href="https://www.mstcecommerce.com/auctionhome/ibapi">https://www.mstcecommerce.com/auctionhome/ibapi</a> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet account by 22.03.2024 till 5:00 PM. Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.
- 3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through NEFT/RTGS mode (After generation of Challan from <a href="https://www.mstcecommerce.com/auctionhome/ibapi">https://www.mstcecommerce.com/auctionhome/ibapi</a> which will provide account details) in bidders Global EMD Wallet account. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. Bids without EMD shall be rejected summarily. The Earnest Money Deposited shall not bear any interest. The amount of EMD paid by the successful bidder shall be adjusted towards the sale price.

- 7. Online auction sale will start automatically on and at the time as mentioned above. Auction / bidding will initially be for a period of 10 Minutes with auto extension time of 10 minutes each till the sale is concluded.
