**E-AUCTION SALE NOTICE**

SALE OF IMMOVABLE PROPERTY MORTGAGED TO THE BANK & MOVABLE PROPERTY HYPOTHECATED TO THE BANK UNDER THE SECURITIZATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT, 2002 READ WITH PROVISIO TO RULE 8 (6) & 6 (2) OF THE SECURITY INTEREST (ENFORCEMENT) RULES, 2002

Whereas **M/s Oracle Metal Recycle (Proprietor: Mrs. Pooja Gautambhai Shah) and M/s Oracle Industries (Proprietor: Mr. Sapan Gautambhai Shah)** have borrowed monies from Indian Overseas Bank against the mortgage of immovable properties & hypothecation of movable properties more fully described in the schedule hereunder and upon classification of the account as NPA, the Bank has issued a demand notice under Section 13 (2) of the SARFAESI Act, 2002 (Act) on **05.08.2019** calling upon the borrower **M/s Oracle Metal Recycle (Proprietor: Mrs. Pooja Gautambhai Shah)**, Guarantors **Mr. Sapan Gautambhai Shah & M/s Oracle Industries (Proprietor: Mr. Sapan Gautambhai Shah)**, [Guarantor / Mortgagor], **Mrs. Rita Gautambhai Shah**, [Guarantor] to pay the amount due to the Bank, being **Rs.1,71,60,032.00 (Rupees One crore seventy one lakhs sixty thousand thirty two only)** as on **31.07.2019** and issued a demand notice under Section 13 (2) of the SARFAESI Act, 2002 (Act) on **05.08.2019** calling upon the borrower **M/s Oracle Industries (Proprietor: Mr. Sapan Gautambhai Shah)** [Borrower / Mortgagor], Guarantors **Mrs. Pooja Gautambhai Shah [Guarantor]**, **Mrs. Rita Gautambhai Shah, [Guarantor]** to pay the amount due to the Bank being **Rs.1,71,81,583.00 (Rupees One crore seventy one lakhs eighty one thousand five hundred eighty three only)** as on **31.07.2019** both payable together with further interest at contractual rates and rests along with costs, charges etc., till date of repayment within 60 days from the date of receipt of the said notice.

Whereas the borrowers, mortgagors, guarantors having failed to pay the amount dues in full to the Bank as called for in the said demand notices, the Bank has taken possession of the secured assets (**which is common security for the borrowers M/s Oracle Metal Recycle (Proprietor: Mrs. Pooja Gautambhai Shah) and M/s Oracle Industries (Proprietor: Mr. Sapan Gautambhai Shah)**) more fully described in the schedule hereunder on **08.01.2020** under Section 13 (4) of the Act with the right to sell the same in "As is where is" and "As is what is" basis under Section 13(4) of the Act read with Rules 8, 9 & 6(2) of the Security interest (Enforcement) Rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking possession was intimated for **M/s Oracle Metal Recycle (Proprietor: Mrs. Pooja Gautambhai Shah)** as **Rs.1,81,36,046.00 (Rupees One crore eighty one lakhs thirty six thousand forty six only)** as on **08.01.2020** & for **M/s Oracle Industries (Proprietor: Mr. Sapan**

**Gautambhai Shah) as Rs.1,81,58,825.00 (Rupees One crore eighty one lakhs fifty eight thousand eight hundred twenty five only) as on 08.01.2020** both payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

The dues of the borrower **M/s Oracle Metal Recycle** as on **23.04.2024** works out to **Rs.3,28,31,189.10 (Rupees Three crores twenty eight lakhs thirty one thousand one hundred eighty nine and paise ten only)** and the dues of the borrower **M/s Oracle Industries** as on **23.04.2024** works out to **Rs.3,31,70,121.36 (Rupees Three crores thirty one lakhs seventy thousand one hundred twenty one and paise thirty six only)** both after reckoning repayments, if any, amounting to **Rs.NIL** subsequent to the Bank issuing demand notice.

The undersigned in exercise of the powers conferred under Sec 13(4) of the said Act proposes to realize the Bank's dues by sale of the under mentioned properties.

## Terms & Conditions

1. The property (ies) will be sold by e-auction through the Bank's approved service provider <https://www.mstcecommerce.com/auctionhome/ibapi> under the supervision of the Authorized Officer of the Bank.
2. E-auction bid document containing online e-auction bid form, declaration, general terms and conditions of online auction sale are available in <https://www.mstcecommerce.com/auctionhome/ibapi>
3. The intending Bidders /Purchasers are requested to register on portal <https://www.mstcecommerce.com/auctionhome/ibapi> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet account by **27.05.2024** upto **05:00** PM, intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.
4. The Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through NEFT/RTGS mode (After generation of Challan from <https://www.mstcecommerce.com/auctionhome/ibapi> which will provide account details) in bidders Global EMD Wallet account. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. Bids without EMD shall be rejected summarily. The Earnest Money Deposited shall not bear any interest. The amount of EMD paid by the successful bidder shall be adjusted towards the sale price.
5. The intending participants of e-auction may download copies of the Sale Notice, Terms & Conditions of e-auction, Help Manual on operational part of e-auction related to this e-auction from e-भ्रय – IBAPI portal (<https://www.ibapi.in>).
6. The submission of online application for bid with EMD shall start from **26.04.2024**.
7. Bidder's Global Wallet should have sufficient balance ( $\geq$ EMD amount) at the time of bidding.
8. Online auction sale will start automatically on and at the time as mentioned above. Auction / bidding will initially be for a period of **120** Minutes with auto extension time of **10** minutes each till the sale is concluded.
9. During the e-auction bidders will be allowed to offer higher bid in inter-se bidding over and above the last bid quoted and the minimum increase in the bid amount must be of **Rs.1,00,000/- for Immovable property & Rs.25,000/- for Movable assets** to the last higher bid of the bidders. **10** minutes time will be allowed to bidders to quote successive higher bid and if no higher bid is offered by any bidder after the expiry of **10** minutes to the last highest bid, the e-auction shall be closed.
10. The property shall be sold to the successful bidder. 19. \*In compliance with Section 194 IA of the Income Tax Act, 1961 income tax @ 1% on the Reserve Price shall be deducted and paid under the PAN of the Purchaser. Since the Tax has been calculated only on the Reserve Price, the bidder shall bear the 1% income tax on the bid multiplier amount and the bank shall not take any responsibility for the same.
