#### Privileges for the Donor of Rs. 1.00 Crore and Above:

- 1. The Donor and his family (not exceeding five) will be provided free accommodation for 3 days in a year in VIP suit having tariff value of Rs.2500/- and above or as changed tariff value as applicable for the said accommodation from time to time.
- 2. The Donor and his family (not exceeding five) will be admitted for Break/Beginning Darshan for 3 days in a year at free of cost.
- 3. In addition to the above, the Donor and his family (not exceeding five) will be provided Suprabhat Darsan for 3 days (VIP Darshan and Suprabhat Darshan must be on different days) in a year at free of cost.
- 4. On any one day as chosen by the Donor in a year, "Veda Ashirvachanam" will be given by Veda Pandits in Ranganayakula Mandapam inside Sri Tirumala Temple.
- 5. Ten Big Laddus will be issued to the Donor as Prasadam during the visit of Donor.
- 6. One Duppatta and blouse piece will be presented to the Donor as "Bahumanam" During the visit of Donor.
- 7. One Gold Dollar of 5 grams in addition to one gold plated silver medallion with the image of Srivaru and Goddess Padmavathi Devi will be given at the time of Donor's first visit only.

- 3. Ten (10) Small Laddus will be issued to the Donor as Prasadam once in a year during the visit of Donor.
- 4. One Duppatta and blouse piece will be presented to the Donor as "Bahumanam" During the visit of Donor.
- 5. One gold plated silver medallion with the image of Srivaru will be given at the time of Donor's first visit only.
- 6. Five Mahaprasadam packets will be issued to the Donor as Prasadam once in a year during visit of Donor.

## Privileges for the Donor of Rs. 1.00 lac and Above:

- 1. The Donor and his family (not exceeding five) will be provided free accommodation for 1 day in ARP Counter in a year or VIP accommodation on payment basis subject to availability.

- 4. One Duppatta and blouse piece will be presented to the Donor as "Bahumanam" During the visit of Donor.

#### **Individual Donors**

- 1. Donors are allowed for darsan through Vaikuntam Q Complex-I only after showing their passbooks taken from the concerned Trust.
- 2. Income Tax certificate and pass book will be issued in the name of Donor.
- 3. Only four members are allowed for darsan along with the Donor, the details of whom should be furnished in advance.

- 4. The Donor and his family members must show their ID proofs during darsan. The Donor has to submit his Life Certificate every year to the TTD Donor Cell.
- 5. If the Donor for any reason unable to come to Tirumala and have Prasadams/Bahumanams/Darsan, then the facilities are provided to a person suggested by the Donor upon submitting the Donor's Life Certificate and an attested ID proof. These details have to be furnished in advance to the Donor Cell, Tirumala, to get the approval.
- 6. The Donor is permitted to change the names of the other four members mentioned in the passbook only thrice in his life time by giving specific reasons and get approval of the Executive Officer, TTD.
- 7. TTD has all rights to make any amendments in the aforementioned rules without informing the Donor in advance.

## **Companies/Trusts/Institutions**

The following conditions are applicable to the Companies/Trusts/Institutions consisting of five members as per the old system.

- 1. These facilities are applicable only to the Director/Managing Director/Managing Trustee/any partner/Employees and their family members.
- 2. The Director/Managing Director/Company Secretary/Managing Trustee/other members of the institution, the names of only five members along with their ID proofs must be officially submitted. These documents must be produced to the Donor Cell, Tirumala, within 15 days to get prior permission.
- 3. The Director/Managing Director/Managing Trustee/other partners/Employees and their family members are allowed for darsan only if they submit a valid identity card. The documents confirming the survival of these institutions must be submitted to the Donor Cell.
- 4. If the aforementioned members of these institutions could not have Darsan/Prasadam/Bahumanam due to any unavoidable circumstances, then the certificates of these institutions, official identity card with authorized signature and the details of the person to whom these facilities must be provided should be submitted to the Donor Cell in advance to get the orders issued.
- **5.** The pass book and Income Tax exemption certificate will be issued to the Donor in the name of the institutions which offer donations.
